NOTICE OF REJECTION

Traffic Management Act 2004

Penalty Charge Notice (PCN) Number: PN1075463A

Thank you for writing to us.

We have carefully considered what you say but we have decided not to cancel your Penalty Charge Notice.

You were sent a Penalty Charge Notice for parking on a double yellow line. Double yellow lines mean no parking at any time, except to load or unload. However, the CCTV camera evidence shows no loading or unloading taking place. Because the rule applies 24 hours a day, seven days a week, double yellow lines do not need to be accompanied by a sign.

You were parked close to a junction. Enforcing the parking rules near junctions helps to keep junctions free of parked vehicles which improves safety. Vehicles can turn in and out more easily and drivers and pedestrians have a clearer view of each other.

You have not provided any evidence or explanation to say why your vehicle had parked there. Your vehicle was observed for over 2 minutes, which is the correct observation time.

You have these choices:

- You can pay the discount charge of £65.00. You have 21 days beginning with the date of service of this Notice of Rejection to do this.
- You can pay £130.00 if you miss the discount period. You have 28 days beginning with the date of service of this Notice of Rejection to do this.
- You can appeal to the Parking Adjudicator using the enclosed form. You have 28 days beginning with the date of service of this Notice of Rejection to do this. The Adjudicator can ask one side to pay costs if he or she believes that they have acted frivolously or vexatiously or has been wholly unreasonable. The Adjudicator is independent and both sides must accept the Adjudicator's decision. If you lose your appeal, you will have to pay the full charge rather than the discount charge (unless the Adjudicator decides otherwise).

If you do nothing


If, after 28 days, you have taken no action, a Charge Certificate may be served on you, increasing the

charge from £130.00 to £195.00. You will then have 14 days to pay the increased charge. If, after the 14 days beginning with the date on which the certificate is served, you have not paid the increased charge provided for in the certificate, you have not paid the increased charge, we may apply to the County Court to recover the money - plus court costs - from you.

- **by phone** 020 8430 2000 (24 hour automated service) using a debit/credit card. Please have your Penalty Charge Notice number ready (see above).
